

PARTICIPATION REGULATIONS

Overcoming brain organoid variability: choosing the right organoid protocol

I GENERAL PROVISIONS

1. The organizer of the training "Overcoming brain organoid variability: choosing the right organoid protocol" is *the Foundation for the promotion of science and development TYGIEL*, hereinafter referred to as the Organizer, registered under KRS number 0000524667 together with partners.
2. The participant of the training may be an entity, a natural or legal person, in particular a student, doctoral student, researcher, representative of the company who meets all the elements contained in part II point 1 of Participation Regulations.
3. The provisions of these Regulations are an integral part of the application for participation in the "Overcoming brain organoid variability: choosing the right organoid protocol" and apply to all participants.
4. Sending an application to the Organizer is tantamount to accepting the present document by the Participant and constitutes a form of concluding obligations between the parties.

II TERMS OF PARTICIPATION

1. The condition for obtaining the status of a participant in the training "Overcoming brain organoid variability: choosing the right organoid protocol" is the joint fulfillment of the following provisions:
 - a) Registration in the online registration system;
 - b) Receipt of registration confirmation from the Organizer via the online system, in case lack of information confirming registration within 48 hours, please contact us at e-mail address – team@tygiel-international.com
 - c) Payment of the registration fee within 7 calendar days from the receipt of the e-mail confirmation of registration, but not later than 10 days before the planned date of the training. If the fee is not paid, the participant will be removed from the list of participants, about which will be informed by email.
2. The organizer reserves the right not to accept the participation application if all places are reserved. The order of applications is decisive, i.e. meeting all the conditions listed in point 1.
3. The organizer provides sending of an electronic certificate confirming the completion of the training, without additional fees from participants.

III RULES OF PARTICIPATION

1. The deadline for online registration for the Training expires in accordance with the information contained on the event website. After this date, online registration will be unavailable, unless the Organizer extends the registration deadline.
2. The right to participate in the Training is granted to students, doctoral students, researchers and other interested parties, entities and individuals.

3. The Organizer determines the Training plan and has the right to make changes to it, even on the day on which the event takes place, including the right to change the time schedule.
4. The organizer is not responsible for technical or organizational problems resulting from reasons beyond his control.
5. The participant bears full responsibility for all materials and information presented by him, including for among others name/logo, advertisements, inserts, banners, stands, roll-ups, presentations, advertising materials. The participant also bears full responsibility for all statements and presentations made during the Training by him or persons delegated by him.
6. The participant undertakes to comply with social rules, instructions and organizational and technical instructions provided by the Organizer.
7. Participants are forbidden to record the training in the following forms: audio, video, image.
8. The participant must possess a computer, smartphone or tablet with Internet connection, built-in or external microphone, optionally a webcam. As well as other software indicated by the instructor about which he will be informed by e-mail or this information will be posted on the website organizer's website.

IV PAYMENTS

1. The condition for participation is the payment of the registration fee within 7 days from the date of receipt of the confirmation of registration and no later than 10 days before the date of the Training. Registration less than 10 days before the event requires immediate payment.
2. The method of making the payment and the deadlines for implementation are regulated on the Training website;
3. The participant has the right to resign from the training not less than 14 days before its planned date.

V RESIGNATION FROM PARTICIPATION IN THE TRAINING

1. A Participant's resignation from participation in the Training may only take place by sending an appropriate message to the e-mail address: team@tygiel-international.com
2. The registration fee and other fees are non-refundable, except for the situation described in part IV point 3 of the present document.

VI PERSONAL DATA PROTECTION

1. The administrator of personal data is the Foundation for the promotion of science and development TYGIEL
2. The Participant of the Training may contact the Foundation in person (at the headquarters), by phone or e-mail in accordance with current information on the website www.tygiel-international.com

3. The Participant's personal data will be processed in order to fulfill the obligations regarding the Training and activities related.
4. Consent to data processing is voluntary, but at the same time obligatory for participation and implementation of resulting obligations.
5. Participants' personal data will be stored for an indefinite period and in accordance with the provisions of the law on the protection of personal data.
6. Participants' personal data may be transferred to entities and institutions cooperating in organizational and publishing works as well as entities related to the Foundation, i.e. Wydawnictwo Naukowe TYGIEL Ltd. In addition, personal data may be transferred only to entities authorized to do so on the basis of the law.
7. Rights:
 - a) the right to withdraw consent to data processing,
 - b) the right to access your personal data,
 - c) the right to request rectification of your personal data,
 - d) the right to request the deletion of your personal data,
 - e) the right to lodge a complaint with the supervisory authority,
 - f) the right to request limitation of the processing of your personal data,
 - g) the right to object to the processing of your data due to a special situation - in cases where the Foundation uses data on the basis of a legitimate interest,
 - h) the right to receive personal data from the Foundation in a structured, commonly used format machine-readable information. The Participant may send this data to another data controller or request that we send his data to another controller. However, we will only if such transmission is technically possible. The right to transfer personal data is only entitled to the data that we process on the basis of the consent received.
8. In order to exercise the above rights, the Participant should contact the Foundation in the manner indicated above.
9. We assure you that we make every effort to ensure the means of physical, technical and organizational protection of personal data against their accidental or intentional destruction, accidental loss, change, unauthorized disclosure, use or access.
